

Judges Committee Continuing Education Units Guidelines

Effective September 1, 2003, all judges will be required to maintain a designated number of Continuing Education Units (CEUs) over a four-year period (July 1-June 30).

Test Judges Only* (Four-Year Rolling Cycle**) 200 TOTAL Credits Competition Judges (Four-Year Rolling Cycle) 300 TOTAL Credits

Judges in More Than One Discipline

Judges who are officials in more than one discipline (i.e., Dance, Singles & Pairs, and/or Synchronized Skating) must maintain a total of <u>one-third of their required Total Credits</u> in the other discipline(s).

Example:

A Singles & Pairs and Dance Competition Judge must maintain 100 CEU credits in Singles & Pairs *and* 100 CEU credits in Dance.

Educational Opportunities

Competitions (Judged, Trial Judged, and/or Refereed)

Competition judges are recommended, but not required, to judge, JET or referee at least one nonqualifying competition per year. In addition, they may trial judge an approved nonqualifying competition for a total of four events during a four-year cycle. Although the number of events listed is recommended, the Judges Committee recognizes the importance of maintaining one's activity in this area.

To receive credit, the official must judge all the events assigned by the chief referee. Trial judges must complete all the events that have been assigned by Judges Committee. The judge will receive full credit in multiple disciplines when there is evidence of judging activity in Singles & Pairs, Dance and/or Synchronized at the same competition.

Qualifying Competition	50

^{*} Synchronized Judges without a Singles & Pairs or Dance Competition appointment must maintain 200 CEU credits.

^{**}Rolling Cycle: first year credit taken off, with fifth year credits added to years 2 through 4.



Tests

Forty tests are recommended, but are not required, to be judged and/or trial judged during a four-year cycle. Moves in the field tests will be credited at 0.5 CEUs per test for those judges who have appointments in both Singles & Pairs and Dance.

Judges Schools/Seminars

Attendance or facilitation at a school or seminar is recommended once during a fouryear cycle, and required for promotion. Credit will be awarded to the discipline covered at the school/seminar.

For seminars that cover multiple disciplines (e.g., Dance, Singles & Pairs, Synchronized Skating), the credit will be divided evenly for those judges who have appointments in more than one discipline.

U.S. Figure Skating three-day schools	65 CEUs

Computer-based learning (per training module)	Varies (set by chair)

Judges Rules Review

The rules review is recommended but not required. Judges will receive CEUs for each section completed and are strongly encouraged to complete all sections applicable to their appointments.
